Our thanks also go to everyone, as members of the PTA, but most of all to the PTA Committee whose drive and enthusiasm has resulted in an outstanding financial contribution to school funds. We have many happy memories of Stocksfest, the vision of Mr Till our Site Manager, drummer and man of many talents, which became reality on a memorable sunny day in June. As school Governors our role is to act as 'critical friends' and make strategic decisions as a group, whilst the operational management of the school remains the responsibility of the School leadership team. Part way through last year the membership of the Senior Leader team (SLT) were reviewed. Leading the team is Mr Hipkiss, Headteacher supported by Mr Endersby, continuing in his role as Deputy Head and Mrs Newton who was newly appointed as Assistant Head.

School Vision and Strategic Priorities

Following Mr Hipkiss's consultation with all stakeholders a newly developed Vision for Stocks Green Primary School was agreed and shared. This vision includes, our vision for our whole School Community, for our Pupils and for our Staff.

This vision underpins the School Improvement plan (SIP) and our strategic priorities continue to be based upon the following themes, Quality of Education, Behaviour and Attitudes, Personal Development, Leadership and Management, EYFS Provision, Buildings and Grounds and finally Governance. Governor Committees are responsible for monitoring priorities and progress which are reported on in their minutes. Committees are responsible for reporting to the FGB whose minutes can be found in the Governor section on the school website. All minutes are recorded by the Clerk to Governors.

Governors ensure that the school fulfils its duty of care through its policies and protocols and above all, training for staff. Policies underpin every aspect of school management and fall under the headings of Statutory, as determined by the DfE, and Non-Statutory which are additional and determined by individual schools. Policies are mostly created by the SLT and staff, Governors review them and they are shared with Parents and Carers, either directly or on the School Website.

Governing Body Membership and responsibilities

We meet both as a full Governing Body and in school subcommittees regularly throughout the year, monitoring the performance of school closely. The sub committees are Finance and Premises (F&P), Pay and Performance (P&P), and Standards and Curriculum (S&C); all meetings are held in school. As Governors we are supported in our expectations by the National Governors Association (NGA) and the Department for Education (DfE).
